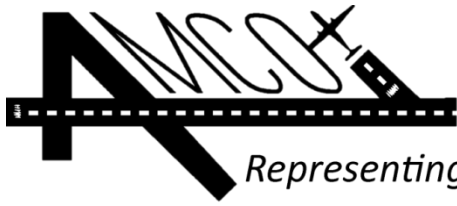

Definition of Membership Categories:

- **Registered Aerodrome Member** – *Any area of land, water (including the frozen surface thereof) or other supporting surface used, designed, prepared, equipped or set apart for use either in whole or in part for the arrival, departure, movement or servicing of aircraft and includes any buildings, installations and equipment situated thereon or associated therewith. (Transport Canada Definition)*
- **Airport Member** – *an aerodrome which Transport Canada has issued an airport certificate to. This member category is further divided into 3 sub categories:*
 1. **Small Airports** – Certified airports which generate \$0 to \$500,000 in gross revenue annually;
 2. **Medium Airports** - Certified airports which generate \$500,001 to \$1,000,000 in gross revenue annually; and,
 3. **Large Airports** - Certified airports which generate over \$1,000,000 in gross revenue annually;
- **Business Member** – *Consulting firms, equipment and material suppliers, and similar commercial organizations which conducts operations in support of airport operations, and which has products or services to sell/provide to the airport industry.*
- **Associate Members** – *non-profit organizations which provide value added to members, such as sharing of information, however does not have products or services to sell/provide to the airport industry. Individuals fall under this category as well.*
- **Sustaining Members** – *Any individual, company, organization or agency making a financial contribution to the Council in excess of \$2,000.00 shall qualify as a sustaining member for the calendar year in which the contribution is made, or for the following year, whichever is more appropriate.*
